CEO Report

BC Budget promises nuggets for employability.

In case you missed it on our social media sites, we attended the BC Budget Lock-Up on your behalf. I am especially delighted about the supports promised for child care and housing, but remain cautiously optimistic that the government will be able to deliver.

Some Highlights for Childcare

 Those making less than \$45,000 will pay next to nothing for child care. This means families who

- currently can't afford to work, will have the opportunity to enter or re-enter the workforce.
- The province promises to create more than 22,000 new licensed child care spaces and is providing financial incentives to service providers to operate outside of standard business hours. Great news for those doing shift work and extended work days.
- Financial incentives are promised to boost the supply of Early Child Care Educators. This will help organizations operating child care centres to find

qualified staff. They will also receive incentives to reduce waiting lists and expand the number of spaces.

For anyone who has dealt with the "house of cards" of child care arrangements, this all sounds too good to be true. If delivered, we could see a large number of employment-ready workers entering the workforce. We could also see employers understanding the economic benefits of offering child care services to their staff.

Some Highlights for Housing

- Colleges and universities are being given the opportunity to borrow money to make it easier to build student housing on campus. This will relieve some of the pressure on market rental housing.
- Controls and taxes are expected to reduce speculative investors in larger urban areas reducing the ratchet effect across the province of high real estate costs.
 The expected result will not only make rental housing more affordable, but will also help reduce "renovictions" and couch-surfing.
- The budget introduced a new "HousingHub" that will coordinate partnerships with local community partners to provide affordable and supportive housing. Some ASPECT members already partner with local and provincial governments to meet demands, and the HousingHub could become a genesis for more of these partnerships to develop.

The budget was a positive move in the right direction toward supporting employability in BC. It will be important for us to continue to engage with government and partners to capitalize on these announcements, and to continue to influence positive change.


